# Job Description: Play Streets Information and Support Officer

#### **About Playing Out**

Playing Out began with conversations between parents who felt that their children (and children generally) were missing out on something vital – the opportunity to play out near home with friends. Due to increased traffic and other barriers, what was common a generation before had become increasingly rare and problematic, with huge impact for children's health and wellbeing.

Then in 2009, Alice and her neighbour Amy came up with the "playing out" or temporary play street model, closing their street to traffic so children could play out freely. This was both a practical action and a catalyst for longer-term change. They got Bristol City Council to pioneer a policy enabling any street community to do this on a regular basis and the idea soon began to spread as it became clear that many people wanted these changes for children and community.

14 years later, Playing Out CIC is an internationally respected and impactful social change organisation, supporting and growing a UK-wide movement to restore ALL children's freedom to play outside where they live, for their health, happiness and belonging in their communities. We support grassroots, community action, particularly the ever-growing play streets movement. With this 'doing/activism' as our platform, we

also campaign for wider change towards safe, liveable streets and a prioritisation of children's need for free outdoor play across local and national policy.

Our main work is promoting and supporting the resident-led 'temporary play street' model which has so far been taken up by over 1,500 street communities (benefitting 45,000 children and involving 22,500 adults taking action in their own communities). Over 90 local authorities across the UK now have a play street policy in place. We are now at a point of significant growth in communities and councils coming on board. We also work in all kinds of other ways to shift thinking and policy about children, streets and cities and have a strong focus on how playing out can bring diverse communities together and benefit children in areas facing greater disadvantage.

We are not trying to do all this alone. The UK-wide Playing Out network is in the thousands and this includes many local activators and community organisations. An important part of our role is to encourage and support this network of local change-makers. We also directly work with councils and collaborate with like-minded bigger organisations such as British Cycling, Sustrans, The Big Lunch and Living Streets. We have a strong board and great support out in the world from experts and academics to councillors and MPs.

#### **Our Team**

We are a small, friendly and committed team, based in our lovely, spacious office at Windmill Hill City Farm, BS3. Alongside this role we have a CEO, a Play Streets Programme Manager and an Operations Officer. We also have two freelance Associates (co-founders of the organisation who are passionate about the aim of restoring children's freedom), working mainly on communications and campaigning.

Playing Out achieves a huge amount through this small team. Mainly, this is because we are not a delivery organisation; we are supporting and growing a network/movement of residents, councils and local organisations who are themselves taking action across the UK. Also, we make full use of digital communications (website, webinars, social media) in order to reach a much wider audience. We are nimble and 'light touch', able to respond quickly to changing needs in a 'can do' way. And as team members, as well as each having areas of responsibility and expertise, we all 'muck in' to get things done in the most effective, resourceful way possible. We work hard and achieve a lot, whilst also prioritizing team wellbeing and supporting a good work/life balance.

#### **About the Role**

This role will support our Play Streets Programme Manager to respond to growing opportunities and interest and enable as many play streets as possible across the UK, using all our existing knowledge, contacts, information and resources. You will also provide direct, light-touch support for play streets in Bristol (about 1/5 of the job) and help us to track activity and monitor the impact of play streets nationally.

We need someone organised, professional, resourceful and encouraging to others. You will be digitally adept and enjoy organising data and information, have excellent attention to detail and accuracy, and take pride in your work. Working successfully to agreed plans and objectives, you will also have room and the ability to spot opportunities and have ideas. You will also be personable and enjoy helping and encouraging people.

This role would suit someone who meets the person specification and wants to use their skills towards bringing about positive change for children and communities; and to learn, grow and develop with the role. You will be happy to be in a small team (with some home/solo working) and to muck in to get things done, in return for an excellent learning opportunity and the chance to be part of an exciting and growing national/international social change movement.

# Supporting the national play streets programme:

- Supporting our Play Streets Programme Manager to grow play streets across the UK
- Responding to a range of enquiries about play streets from parents, residents, councils, community organisations etc. Signposting and providing helpful information, contacts and encouragement.
- Pro-actively contacting local authorities and other organisations nationally to promote play streets and offer support
- Keeping our national Facebook group (online community) active and supportive
- Providing information and support as needed to our network of local 'activators'
- Co-ordinating specific national projects such as our 'free kit' offer for play streets
- Providing support for communications around play streets, including mailings and social media
- Co-ordinating, servicing and feeding into online network meetings
- Helping to organise and deliver in-person events and training
- Occasionally being willing to travel to meetings/workshops outside Bristol

- Writing up and summarising results of evaluation for internal and external use

- Where capacity allows, attending events in Bristol to promote play streets
- Responding to interest from Bristol residents and providing light-touch support (phone, email and, where capacity allows, in person)
